Subscription Agreement for **Vigeoweb site**, a service by **Vigeosoft USA Corp.**

If you purchased your domain with us, we will manage the DNS for you.

If you are using an existing domain with your new Vigeo**website** account, you will need to update the nameservers to point to the nameservers listed below:

Nameserver 1: ns1.vigeo**website**.com

Nameserver 2: ns2.vigeo**website**.com

Nameserver 3: ns3.vigeo**website**.com

In order to update your domain's name servers you must contact the domain registrar or company you purchased the domain from.

Name server updates typically take 12 to 24 hours, though in some cases the propagation of the change can take up to 72 hours.

## Domain Transfer

We can register about 500 different domain names and although the vast majority of these domains can also be transferred to us, there are a few domains that you can not transfer us: ac, sh, bz, nu, be, tc, vg, ms, cm, gs, jp, net.nz, co.nz, org.nz, com.mx, at, am, nl, it, fm

Here is important information you need to know if you want to transfer your domain:

We are not responsible for domains that expire prior to a successful transfer. You do not lose any time, or pay for overlapping months. With the exception of .eu domain names, transfer adds a full year to the current expiration date.



Transfer authorization code: Is a security code that indicates you have the right to transfer the domain name. Transferring .com and .net domain names requires an EPP transfer authorization code. Please contact your current registrar to obtain this code prior to submitting your transfer request.

For .eu domains: The current registrant contact email address will receive email from the .eu registry (EURid) which needs to be approved within 7 days of the transfer order. The new expiration date of the domain will be 1 year from the completion date of the transfer.

## Domain Name

With all the Vigeoweb site Plans we include free, for the first year only, the registration of a .com, .net or .org Domain Name.

Also you can use an existing domain, see DNS Management or if you wish you can transfer your domain with us.

## Unlimited Domains

Your website can have more than 1 domain name pointed to it and all return the same website.

Suppose that with your Vigeoweb site Plan you acquired yourdomain.com, then from the clients area, you can acquire for example: yourdomain.net and yourdomain.org and also you point both domains to your website. ## Rewards Program
